The City Council of the City of Talladega met in a regular meeting on Monday, July 7, 2022 at 5:00 p.m. in the Talladega City Hall Chambers. The meeting was called to order and the following were present: Council President Horace Patterson, Council Member Vickey R. Hall, Councilman Joe Power, Council Member Betty Spratlin, Councilman Trae Williams, and City Manager Seddrick Hill.

Invocation by Pastor Justin Milliken from Hepzibah Baptist Church.

Motion by Councilman Williams with a second from Council Member Spratlin for the approval of the amended agenda. AYES: All.

Motion by Councilman Williams with a second from Council Member Hall to approve invoices and expenditures. Roll Call. AYES: All.

Council President Patterson deferred to Reverend Hugh Morris to present to students from the City of Talladega and Talladega County the NAACP Scholarship recipients.

Motion by Council Member Spratlin with a second from Councilman Williams for the approval of Jay Cooper's application to the Talladega Municipal Airport Board. Roll Call. AYES: All.

Brought before the Council was an informational item concerning the Back-to-School Sales Tax holiday scheduled for 12:01am on Friday, July 15, 2022 and ends at 12:00 midnight on July 17, 2022. The information will also be posted to the City's website.

Mike Brewer from East Alabama Regional Planning and Development Commission came before the Council to present an initial draft of proposed ward boundaries. It was commented that the target population in each ward was 3,172 people. It was also noted that Ward 1 had the highest number of populations with Ward 4 receiving the smallest number. There was a question as to the loss of some voters for some wards. Mr. Brewer stated that it was necessary to have equal representation throughout the City and every ward should get close to that target so each vote carries the same weight. It was also mentioned that links to the draft would be made available.

Council President Patterson deferred to City Attorney O'Brien. Attorney O'Brien announced that the City was now the owner of the AJ's building.

Ordinance #1909 amending Ordinance #1614 and adopting revised rules and regulations pertaining to Compensation incentives to classified service members for continuing education

There were some questions as to the cost of the program to the City and it was requested that time be allowed to review the ordinance as the revised ordinance would not receive the necessary time to look into. City Manager Hill commented that the program was much needed in order to recruit and retain qualified personnel.
