The meeting was called to order and the following were present: Council President Horace Patterson, Council Member Vickey R. It was mentioned that the drawings were 90% complete and that the items needing to be wrapped up were the structural details for the pavilion and footings on the site, electrical drawings, and irrigation plans. Mr. O'Brien also stated that the project manual would next need to be assembled and out to bid to contractors; also, based on the amount of work remaining, it would be 3-4 weeks before bids could be sent. He also stated that construction should begin in the fall with a 6–8-month construction period depending on materials and furnishings.
