Dear Customer,

According to the policy for garbage exemptions, all customers requesting exemption for garbage fees must renew each year. The exemption requirements are as follows:

1. Sole income is derived from Social Security benefits, Supplemental Security Income (SSI), or a combination of the two. (Total household income)
2. The Garbage Fee Exemption Form must be filled out. (form enclosed)
3. Provide a copy of most recent bank statement for proof of income.
4. Provide copy of letter from Social Security Administration stating income.
5. Provide copy of power bill.
6. Provide names of all occupants living in your household. All occupants must report their income on attached sheets.
7. Provide Photo ID.

Once the form and requirements have been provided, we will determine if you meet the requirements for exemption from garbage collection fees. You may bring the required documents to the main office of Talladega Water & Sewer or mail them to the address on the enclosed form by December 31st of this year in order to be exempt for the next year. POLICY FOR GARBAGE EXEMPTIONS

THIS ADMINISTRATIVE PROCEDURE WILL APPLY TO EVERYONE EVEN IF IT HAS ONLY BEEN A FEW MONTHS SINCE YOU HAVE APPLIED FOR EXEMPTION.

All accounts must be paid up to date before an exemption will be granted. This includes an previous balances from a previous location. **We can only grant exemption for the address that you are currently residing.**

Applications for exemptions will be renewed every year during the month of January for people currently exempt. New applications will be accepted throughout the year if you qualify for the program. The exemption applications shall be delivered in person to the main office of the Water and Sewer Department and must include all income verification documents necessary to grand and exemption along with a copy of your current power bill & picture ID. ALL paperwork must be submitted or you will be subject to pay any balance on your account that is due when you submit your application. **ALL DOCUMENTS REQUESTED MUST BE LISTED IN YOUR NAME.** You will be able to download a copy of the exempt application from our website at www.talladega.com or the application will be available to you in the main office of the Water and Sewer Department. Please fill out the application and return it along with all annual income verification copies required to:

You will still be responsible for showing current total household proof of income. Anything sent to us will be considered a copy and will not be returned. The application along with copies of all required verification should be delivered to Talladega Water and Sewer Department and then the application will be reviewed, a decision will be made and a copy will be sent to you by mail. **WE MUST RECEIVE PROPER CURRENT (PRESENT YEAR) COPIES OF ALL REQUIRED PAPERWORK OR YOUR EXEMPTION COULD BE DENIED OR DELAYED.**

INCOME THAT MUST BE CLAIMED INCLUDES: SS, SSI, ADC, FDC, CHILD SUPPORT, VA RETIREMENT PAY, PENSION PAY, AND 401Ks AS WELL AS JOB INCOME.

YOU MUST LIVE AT THE RESIDENCE THAT YOU ARE REQUESTION EXEMPTION FOR AND THE ACCOUNT MUST BE IN YOUR NAME.
